

HISTORICAL STUDY TOUR INFORMATION

PRICE GUARANTEE: The price quoted is based upon a minimum number of participants, subject to adjustments. If the minimum is not met or in the event of an imposed increase in air or motor coach fare due to circumstances beyond the carrier's control (fuel surcharges, departure taxes, security and or baggage fees, etc.), an HST price change will be based entirely upon the carrier's increase.

REGISTRATION FEE: A \$200.00 non-refundable registration fee is required for all HST participants payable to: LAB. This officially registers the participants for their school's HST.

FEE PAYMENTS: All HST participants will make payments based upon their school's payment schedule. The HST must be paid in full no less than thirty (30) days prior to DAY ONE of the school's departure date. The school will establish a pre-arranged payment schedule with the HST vendor...thus eliminating "family to vendor" financial correspondence. All "late" payments will be subject to a 10% penalty fee assessed to the corresponding payment amount due. This applies to families and to the school.

CANCELLATION/REFUND POLICIES: The following policies will be effect-

1. HST vendor will retain 25% of the base trip price if the request, made in writing, is postmarked no later than one hundred twenty (120) days prior to Day One of the departure date.
2. HST vendor will retain 33% of the base trip price if the request, made in writing, is postmarked no later than ninety (90) days prior to Day One of the departure date.
3. HST Vendor will retain 50% of the base trip price if the request, made in writing, is postmarked no later than sixty (60) days prior to Day One of the departure date.
4. HST vendor will retain 100% of the base trip price for all refund requests made fifty nine (59) days or earlier prior to Day One of the departure date.
5. For California Residents only-upon cancellation of the HST, where you, the participant, are not at fault and have not cancelled in violation of the aforementioned policies, a 100% return of all payments will be promptly refunded to the school. It will be the school's responsibility to refund the appropriate payments to the HST participants.

GENERAL POLICIES: Reservations are generally non-transferable. The right is reserved to make additions or deletions in the program deemed advisable for the well-being of the group or for changes in circumstances. The HST vendor does not accept any responsibility for lost or stolen items.

MEDICAL CONTINGENCIES: Accident, illness, or dental-related insurance is not provided by the HST vendor. Limited “over-the counter medications will be available and dispensed in accordance with school policy. Students requiring daily medications will be subject to official school personnel supervision. The sponsoring school maintains a comprehensive liability insurance.

LAB PERMISSION FORMS: All HST participants will be required to obtain an official school permission form and have it signed and notarized to facilitate specific situations that may occur on the HST.
